## College Level Coursework

- ❖ Mt. San Antonio College accepts foreign coursework whose evaluation reports have been certified by NACES® (National Association of Credential Evaluation Services) & AICE® (Association of International Credential Evaluators).
- ❖ If you are submitting **COLLEGE/UNIVERSITY** transcripts, make sure that the evaluation is a “Detailed or Comprehensive” and that it includes the following items:
  - Lower and Upper division course specifications
  - Name of the Institution, dates attended, degrees earned, and graduation dates
  - List the semester unit value and grade equivalencies
  - Calculates an overall Grade Point Average (G.P.A.)
- ❖ The official transcript must be mailed to: Mt. San Antonio College, Admissions & Records, 1100 N. Grand Ave, Walnut, CA 91789.
- ❖ **F-1 International Students (UNDER 18-years-old)**: You must submit an evaluation that verifies your high school transcript is equivalent to the *completion of a U.S. high school diploma*.
